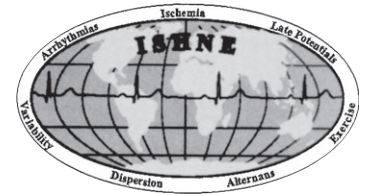

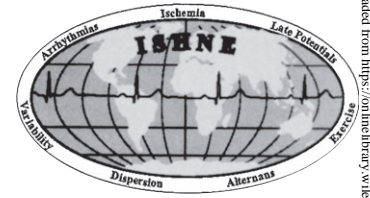

### 1.- SCOPES OF *ISHNE*:

- c) **Educational Program:** Important international educational activities take place yearly, mostly related to all major cardiological meetings around the world, such as ACC, AHA, ESC, Cardiostim and the *ISHNE* Biennial Congress. Also local educational activities are organized worldwide.

## MANUSCRIPT PREPARATION

Online submissions: follow the directions in <http://mc.manuscriptcentral.com/ANEC>. These do not supersede the general style and formatting detailed below. Please prepare the manuscript file as you would a paper copy for review with a title page, abstract, complete text, tables, figure legend, figures and reference all together in a single electronic file before uploading.

## Title Page

Some of the following will be duplicated in the electronic submission. Include full name(s), degree(s), and affiliation(s) of author(s); list under title. Include affiliation of a commercial or industrial employee.

Provide a running title of 3 to 4 words.

At the bottom of the page, include information about financial support, i.e., grants, if applicable.

Address for reprints: followed by full name, mailing address, telephone and telefax numbers; and e-mail address.

## Abstract

Abstract should be after title page and numbered page 1. The abstract should be structured with the following headings: Background, Methods, Results, and Conclusions.

Abstract should not exceed 250 words. At the end of the abstract, provide a maximum of 6 key words suitable for indexing.

Standard abbreviations should be used for all measurements (see "Style Manuals").

## Text

The text should follow the abstract and begin on a new page, as should references, legends, and tables. The text should include the following main headings: Methods, Results, and Discussion. Do not use a separate heading for Introduction.

Abbreviations should be minimized. Those used should be defined when they first appear; afterwards they may be used.

References should be cited in numerical order, as should tables and figures. Only written Personal Communications may be referenced, and they must be available upon request. Unpublished data may not be used, and reference should not be made to abstracts.

As a guide for manuscripts, there should be no more than one figure or table for every 750 words. The manuscript should not exceed 6000 words.

## References

List all sources in the reference list alphabetically by name. In text citations should follow the author-date method. This means that the author's last name and the year of publication for the source should appear in the text, for example, (Jones, 1998), and a complete reference should appear in the reference list at the end of the paper.

References are styled according to the sixth edition of the *Publication Manual of the American Psychological Association*. A sample of the most common entries in reference lists appears below. Please note that for journal articles, issue numbers are not included unless each issue in the volume begins with page one.

Should supplement not duplicate the text.

Should be numbered consecutively in order of appearance in the text.

Each must be given an Arabic numeral and a title, placed at the top of the page.

Abbreviations used in a table should be footnoted and explained in alphabetical order.

Any material that is not self-explanatory should be footnoted.

Submit written permission from publisher(s) and author(s) for any table that has been published previously.

## Legends

Each figure should have a corresponding legend that should not duplicate the text.

Identify all abbreviations used in a figure at the end of each legend.

Use standard abbreviations for measurements.

## Figures

Electronic submissions: note acceptable formats. More information can be found at <http://authorservices.wiley.com/bauthor/>.

Black and white illustrations are published without charge to the author. Special arrangements for color illustrations must be made with the publisher at a cost of \$850 (US) per page (one side).

Submit written permission from publisher(s) and author(s) for any figure that has been published previously.

Photographs in which a patient or other person is identifiable must have his/her written permission available.

The consent must state specifically what the person is consenting to and what restrictions, if any, the person has placed upon the publication of the photograph. All restrictions must be strictly observed.

## Case Reports

Electronic submissions. A case report may not exceed 6 pages, including all typed material (text, references, legends, tables, etc). The abstract for a case report should not exceed 100 words. Reports about one or two cases will be defined as a "case report".

## Letters to the Editor

Electronic submissions. Letters should not exceed 500 words even if describing a clinical or scientific event. The usual **A.N.E.** format will prevail. In most instances a letter should be about a specific article that appeared in **A.N.E.** A response will be solicited from those authors.

## Style Manuals

The following is a guide to writing scientific papers and provides standard abbreviations for measurements and other scientific terms: CBE Style Manual, prepared by the Committee on Form and Style of the Council of Biology Editors, the American Institute of Biological Sciences, Arlington, VA, 1978.

The manuscript should also follow "Uniform Requirements for Manuscripts Submitted to Biomedical Journals, 3<sup>rd</sup> Edition." *Ann Intern Med* 1988; 108:258-265 and *Br Med J* 1988; 296:401-405. Where uniform requirements differ, the **A.N.E.** instructions prevail. The APA Style Manual is a useful reference.
